Mr Hunter moved approval of the April 3rd minutes. Mr Vensil Vote was 3 yeas.

Chief Bourne gave the April police report

Mr Hunter reported that preliminary checks of roads that would qualify for OPWC money puts Old Riley as the highest priority. Fiscal Officer stated that up to \$175,000 could possibly by designated for road maintenance this year.

The backhoe engine repair is delayed waiting on parts.

Check for \$45,000 has been received from the Village of Frazeysburg as payment for Frew Park. Fiscal Officer has contacted Hunting Bank regarding closing the note with a final payment for a total of \$40,635.26. Mr Vensil moved to amend the appropriation in the General Fund to reflect the deposit and transfer said amount to the Frew Park Fund for payment. Mr Hunter 2nd Vote was 3 yeas.

Fiscal Officer received verification from County Auditor that a new cemetery levy at .45 Mil would generate \$28,361.46 annually for cemetery maintenance. Mr Vensil moved to go forward Mr Hunter 2nd. Vote was 3 yeas.

Mr Freas requested discussion of a power post driver in anticipation of all the posts that will need placed for the new signs due to arrive soon. Decision was tabled pending the arrival of said signs.

Cemetery deed was signed for the Hockenberry family.

Zack Guthrie requested discussion about placing woven wire on the cemetery fence bordering his property to prevent decorations from graves blowing across his field. Mr Hunter will contact a fence contractor.

Jamie Johnson is working on acquiring fireproof filing cabinets to house cemetery records in the cemetery garage.
