Discussion was held regarding cemetery plots that were sold to an out of township resident at resident prices. It was decided the purchaser had been in discussion since before the price change and had family in township that the resident price be accepted.

Mr Freas stated that cleanup of the property on Canon Rd had started but had not progressed.

Mr Freas was granted approval to have the AC on road equipment repaired.
